Our story



Rolland and Heidi Baker began Iris Global (formerly Iris Ministries) in 1980, moving to Mozambique in 1995. Since then the Bakers have been at the forefront of a massive outpouring of the Holy Spirit in Mozambique and south eastern Africa that has seen thousands come to Jesus. Iris Global continues to grow and today has over 60 locations across the world including in South Africa, Malawi, Kenya, Uganda, Brazil, Cambodia and over 30 other countries.

Iris Global UK was established in 1994 to help give financial support to the work of Iris Global bases in Mozambique and around the world.

Iris Global is empowered by the love of God the Father, the Son Jesus Christ, and the Holy Spirit, to stop for the one in need through adoration, outreach, education, relief, development, healing and the arts.

Adoration – our main purpose is to love God and have fellowship with Him.

Outreach – to serve the poor, the destitute, the lost and the forgotten.

Education - investing in people, strengthening communities and sharing God's love.

Relief – bringing spiritual and physical peace to those affected by disaster.

Development – pursing practical and tangible means of satisfying physical needs.

Healing – We do not rely on ourselves but on God, and expect miracles of all kinds.



You can contribute

Making a will is a great opportunity to think about what is important to you and to ensure your wishes are carried out posthumously. If you don't make a will the law will decide who inherits your property.

One of the ways you can support our ministry is to include a legacy for us in your will <u>after</u> you have ensured your family are provided for.

There are three types of legacies:

1. A share of your estate

Many people choose to leave a share of their estate to charity. This can be a percentage of what is left over once loved ones are provided for or it can be any percentage you like. As this gift is a proportion of your estate it keeps pace with inflation.



2. Fixed sum of money

You can choose to leave a sum of money, also known as, a pecuniary gift. You can choose any amount you like. It is worth reviewing this from time to time as inflation can reduce its value.

3. Gift of a specific item

You can leave a particular item such as a piece of jewellery, an antique or even a property. A gift like this should be named in your will.

Make a list of the people to whom you would like to leave a gift, and any causes that you would like to benefit. We believe that you should provide for your family first, after this you can consider leaving a gift to one or more charities, such as Iris Global UK. It is also a good idea to list the things you own and anything you owe so your executor can work out the value of your estate.

If you do not have a will and would like to leave a gift to Iris Global UK:

Please speak to a solicitor who specialises in will's, probate and tax matters. They will help you to create a will that is legal and valid. You can use this website https://solicitors.lawsociety.org.uk to find solicitors in your area.

If you already have a will but would like to leave a gift to Iris Global UK:

Please complete a Codicil, which is a simple way to made additions or changes to your will without re-writing it. A Codicil must be signed and witnessed in the same way as your will and kept alongside your will. A codicil must NOT be attached to your will in ANY way e.g. paper clip or staple, it must simply sit with it.

Please ask us for a blank Codicil form if you do not have one.
